Impeachment of Senator Abbegglen, Ombudsperson Doran

- 1. He has failed to meet the needs of his constituency, Ombudsperson has tried to communicate with no response so we will be moving forward with an impeachment proceeding. We began with a formal reprimand, as he continued to fail to fulfill with duties we would continue to move up with disciplinary action. We move to impeachment.

Budget for Peer Assistants - Director Gupta

1. Gupta: finance committee recommends we fund the PA's in full of \$8, 550 events have been enjoyed and used by students in the past

2. Questions:

- a. Senator Smerillo: have we funded these amounts in the past?
 - i. Gupta: PA's have a block budget, we haven't funded them yet this year because they didn't come to Senate last year. They got \$7 per students from a raised student government fee.

3. Discussion:

- a. Senator Zaun: we are making up the discrepancy of their usual budget, I don't think this is out of the ordinary.
- b. Senator Johnson: call to question
 - i. Second to Senator Smerillo
- 4. Vote: ayes have it, the budget is approved

Senator Nelson: do we have a celebration for Veteran's Day?

- 1. Co-President Bhakta: I don't think so, not in the past
- 2. Chair Johnson: your constituent should stop by for community comment
- 3. Senator McDonald: I would appreciate it if we did something, but I don't think it would make a difference except for showing respect for ROTC students. We should send something out, but I don't think it's a big deal around our area since it's so small.
- 4. Ombudsperson Doran: I think this is a good question of how we celebrate federal holidays. How do we take initiative as students to celebrate what we want to celebrate; if you want to celebrate, organize something.

Senator Schaaf: there needs to be more safe rides at night from a constituent. How do other people feel?

1. Discussion

- a. Director Concepción: There is only one van so far that seats 5.
- b. Senator Smerillo: I charge the Student Academic Affairs Committee to look into talking with Campus Safety to using a second van in the cold months
 - i. Second: Speaker Ellingson

c. Discussion

- i. Chair CarlsonSather: Campus Safety officers are available to give people rides to bring you across campus.
- ii. Ombudsperson Doran: I support the spirit, but I am worried seeing past senators trying to get funds reallocated from Campus Safety, but the large institution is a barrier. I suggest we amend the motion to be finding ways for students to more effectively use saferides. I think this is as feasible as we would hope.
- iii. Senator Schaaf: It would be harder to push for this, but I think it's important to acknowledge the issue and to gauge the feelings of the Gustavus community.
- iv. Co-President Bhakta: they don't have the workers for the vans, the shortage makes it hard to operate. We could amend the charge to make a higher incentive to be a safe rides driver.
- v. Advisor Ruble: I oversee Campus Safety, drivers are a problem, number of vans available are a problem. In the future, the community service van and safe rides would be in service in the evening.
- vi. Senator Smerillo: advising students to carpool and take rides from campus safety would not let us get to efficiency. As a CF there are times we have to wait 10-15 minutes to get to an urgent situation. I like the idea of the community service van.
- vii. Parliamentarian Boyden: The post office has been asking to get a new van for a while, amending the charge to do information to students.

- viii. Senator Young: the charge is talking with campus safety.
- ix. Senator Hietpas: I understand there is a shortage of vans, I know that campus owns vehicles that can be used, we discuss whoever owns the vans if we can use those.
- x. Senator McDonald: people can call multiple times, there could be people to walk across.
- xi. Ombudsperson Doran: motor pool vans are by athletic fields. Those could be a good option when available, but they are used by student organizations. In reality, there is likely some tension on that idea because they want to make sure they're available to reserve.
- xii. Co-President Bhakta: committee is available to reach out to start the process.
- xiii. Senator Smerillo: People order a safe ride and then leave because it takes too long. Modifying the program to expedite the process. If you order a safe ride, wait for it or call to cancel.
- xiv. Senator Johnson: would it be possible for us to use personal vehicles? Like a mini-uber with reimbursement?
- 2. Vote: ayes have it, Student and Academic Affairs Committee is charged.

Senator Lim, looking into getting a rail for Rundstrom.

 - h. Senator Lim: I like Chair Johnson's fix, and issue is preventing people from slipping
